Sharpe Ratio: Average return earned in excess of the risk-free rate per unit of volatility or total risk. Subtracting the risk-free rate from the mean return, the performance associated with risk-taking activities can be isolated.

Sortino Ratio: Measures the risk-adjusted return of an investment asset, portfolio, or strategy. It is a modification of the Sharpe ratio but penalizes only those returns falling below a user-specified target or required rate of return, while the Sharpe ratio penalizes both upside and downside volatility equally.

Standard Deviation Known as historical volatility and is used by investors as a gauge for the amount of expected volatility.

Upside Capture Ratio: Statistical measure of an investment manager's overall performance in up-markets. The up-market capture ratio is used to evaluate how well an investment manager performed relative to an index during periods when that index has risen.

Downside Capture Ratio: Statistical measure of an investment manager's overall performance in down-markets. It is used to evaluate how well an investment manager performed relative to an index during periods when that index has dropped.

An upside capture ratio over 100 indicates a fund has generally outperformed the benchmark during periods of positive returns for the benchmark. Meanwhile, a downside capture ratio of less than 100 indicates that a fund has lost less than its benchmark in periods when the benchmark has been in the red. A negative downside capture indicates the fund has gained when its benchmark has been in the red. All bond funds' ratios are calculated relative to the Barclays Capital U.S. Aggregate Bond Index.

Launched in 2010, Leader Total Return Fund has focused on maximizing total return potential through the ups and downs of bond market cycles. The Fund is a diversified portfolio of bonds across various fixed income sectors that is actively managed to maximize return and generate a high level of income.

A Broader Opportunity Set: The fund invests in a diversified portfolio of fixed income securities across multiple asset classes, taking advantage of dislocations and opportunities across various sectors.

Opportunistic Approach: The Fund's experienced managers look for strategic entry points across asset classes and single securities.

Higher Income Potential: Access to a wider range of income opportunities means the fund may offer higher income potential than other short-term investments.

Market & Fund Commentary

Equity markets continued their intense sell off into December alongside high yield credit with only some relief and the last few days of the year. Trade wars and fears of a global slowdown looked to be the main drivers. It seems that the market is pricing in a deterioration of fundamentals, which will make the next earnings season interesting. Key technical levels across the major indices were lost and approached bear market territory. After November, we began accelerating our defensive posture across all our funds.

High Yield Credit spreads continued steep widening over December from November alongside the equity markets sell off (+57bps). Investment Grade spreads also continued moving wider (+12bps). Treasuries yields finally tightened only slightly during the course of December, with the yield curve flattening. The Federal Reserve hiked in December as expected and left room for 2 more hike in 2019. It seems though as if the market is pricing in a pause come March 2019, which would explain the yields across the curve falling. We still find certain floating rate bonds attractive to take advantage of rates on the front end of the curve while yields remain off their historical lows, but stress the importance of credit quality.

We continued moving the portfolio to be more defensive with 99% IG 1% HY vs last month of 86% IG 14% HY. Exposure to Agency Mortgages decreased as flows into the fund came in. We added some duration during the month of December to take advantage of falling yields as we've seen inflation expectations fall through key levels. We've also let a cash position build up as we watch from the sidelines the market falls and wait for opportunities to deploy cash.

We continue to look for opportunities across asset classes. As mentioned above, we have moved towards a defensive posture; We are currently not adding to high yield corporates or high yield debt in general. We have added some duration to the portfolios via treasuries and continue to remain nimble in that arena. We also have our eyes on the convertible bond space as we can lock in higher yields as prices have come in. We continue to monitor inflation expectations and key technical levels on the 5-Year and 10-Year US Treasury yield for entry points.

Definitions:

S&P 500: Standard and Poor's 500 Index is a capitalization-weighted index of 500 stocks. The index is designed to measure performance of the broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.

CLOs: Collateralized loan obligations (CLOs) are a form of securitization where payments from multiple middle sized and large business loans are pooled together and passed on to different classes of owners in various tranches. A CLO is a type of collateralized debt obligation.

Basis Point ("bps"): one hundredth of one percent, used chiefly in expressing differences of interest rates
