Dear Mr. President,

The benefits to your current negotiations of ending this event are as follows:

- 1. It would demonstrate that the USA stands for the humane treatment of not only humans but animals.
- 2. There are more than 46 million households that keep dogs as pets in the USA, including mine. I believe 100% of the voters, approximately 100 million that own pets, would view your administration in an extremely positive manner in taking steps towards ending such cruelty.

- 3. Such a development would clearly demonstrate that the common Democrat rhetoric, that it is "all about money" for the current administration, would have no basis in fact.
- 4. It would also allow the Chinese an opportunity to demonstrate that they care about both people and animals, bolstering their moral standing in the world that is seen by many as lacking.
- 5. Lastly, it is extremes that tip the needle; the photos of this festival are so horrific that most Americans would applaud such an effort, driven by a truly pioneering President and First Lady.

For my part, my motivation is as a dog owner and lover - a photo of mine is attached. It is heart breaking to see this festival continues to exist and I believe that the Trumps can eradicate this behavior.


I hope you will consider this in light of the timing of the forthcoming festival (June 19, 2019), as another example of the great things you are doing, and lastly, because it is just wrong.
