Sharpe Ratio: Average return earned in excess of the risk-free rate per unit of volatility or total risk. Subtracting the risk-free rate from the mean return, the performance associated with risk-taking activities can be isolated.

Sortino Ratio: Measures the risk-adjusted return of an investment asset, portfolio, or strategy. It is a modification of the Sharpe ratio but penalizes only those returns falling below a user-specified target or required rate of return, while the Sharpe ratio penalizes both upside and downside volatility equally.

Standard Deviation Known as historical volatility and is used by investors as a gauge for the amount of expected volatility. Upside Capture Ratio: Statistical measure of an investment manager's overall performance in up-markets. The up-market capture ratio is used to evaluate how well an investment manager performed relative to an index during periods when that index has risen.

Downside Capture Ratio: Statistical measure of an investment manager's overall performance in down-markets. It is used to evaluate how well an investment manager performed relative to an index during periods when that index has dropped.

An upside capture ratio over 100 indicates a fund has generally outperformed the benchmark during periods of positive returns for the benchmark. Meanwhile, a downside

Market & Fund Commentary

Equity markets finally pulled back in May as trade headlines dominated again after trending straight up through April. The Dow, Nasdaq, and S&P all broke below their 200-day moving averages by the end of May. The Transportation Index also broke below its 200-day moving average earlier on in the month. This added level of volatility in the markets now gives us pause in terms of risk assets. We've seen interest rates rally over the past month. The mood and trend of the markets have completely changed over the month of May. We believe a defensive posture is warranted here until we gain some clarity on technical levels and fundamental headlines.

High Yield credit spreads widened over May from April (+70bps) alongside declining equity markets. Investment Grade spreads also widened over May (+13bps). Treasuries yields rallied tremendously in May as the 2yr treasury yield fell from 2.267% to 1.924%, breaking that 2% level. 2yr and 5yr US Treasury yields re-inverted. The 2yr and 10yr yield gap has remained the same at roughly 24bps. The curve remains flat, and the 10 year is only 12bps from breaking 2%. The markets are pricing in cuts going forward from the Fed. The continued flatness of the curve stresses the importance of credit quality in fixed income portfolios. We continue to believe it prudent to maintain credit quality, but at the same time, be nimble enough to step in on any beaten down opportunities.

The portfolio continues to remain largely defensive with 90% IG (up slightly over last month). During the month of May, we added some duration into the portfolios to protect the funds against any credit risk. We took some high yield exposure when gains presented themselves (i.e. sold Sprint bonds post T-Mobile/Sprint recent announcement).

We continue to look for opportunities across asset classes. We added some other credits over the month in addition to trimming our energy exposure to build out yield. We continue to monitor inflation expectations and key technical levels on the 5-Year and 10-Year US Treasury yield for entry points. We also see some opportunities in short WAL ("weighted average life") CLOs.

Definitions:

S&P 500: Standard and Poor's 500 Index is a capitalization-weighted index of 500 stocks. The index is designed to measure performance of the broad domestic economy through changes in the aggregate market value of 500 stocks representing all major industries.

Dow Jones Transportation Index: The Dow Jones Transportation Average is a price-weighted average of 20 U.S. transportation stocks. The average as it is known today began on October 26, 1896. It was formerly known as the Dow Jones Railroad Average..

CLOs: Collateralized loan obligations (CLOs) are a form of securitization where payments from multiple middle sized and large business loans are pooled together and passed on to different classes of owners in various tranches. A CLO is a type of collateralized debt obligation.

Basis Point ("bps"): one hundredth of one percent, used chiefly in expressing differences of interest rates
